
1. Call Meeting to Order at : P.M./Pledge Allegiance/ Roll Call/ Establish Quorum.

Gov't Code sec 551.042. Each member of the public is limited to 3 minutes or 6 minutes for members of the public who require a translator.
3. Public Hearing on the Proposed Desired Future Conditions for Groundwater pursuant to Tex. Gov't Code §36.063.
4. Consider, deliberate, and take possible action to adopt and approve the Desired Future Condition for the District to meet Groundwater Management Area 16 (GMA-16) Requirements.
5. Consider, deliberate, and possible action to authorize requesting financial participation from the Texas Water Development Board, authorizing the filing of a application for financial participation, and making certain findings in connection therewith.
6. Consider, deliberate, and take possible action on the minutes for May 27, 2026, by the board of directors.
