Notice is hereby given that a General Meeting of the governing body of the above-named political subdivision will be held on Wednesday, July 29, 2026, beginning at 6:00 P.M., in the conference room of the Duval County Groundwater Conservation District. The district office is located at 231 E. Railroad Avenue, Benavides, Texas. Duly posted notice of said meeting.

1. Call Meeting to Order at ___:___ P.M./Pledge Allegiance/ Roll Call/ Establish Quorum.
2. Members of the public may address the Board regarding items on the agenda pursuant to Tex. Gov't Code sec 551.007; and members of the public may make inquiries of the Board According to Tex. Gov't Code sec 551.042. Each member of the public is limited to 3 minutes or 6 minutes for members of the public who require a translator.
3. Consider, deliberate, and take action on proposed changes to District Rules.
4. Consider, deliberate and take possible action on the report of Dr. Veskatesh Uddameri, Ph.D., P.E., on Brown N. Calwell Hydrogeological E-log and Lab report. (Pending well logs TDLR.) Provided by Cielo Vista Solar LLC, Cielo Vista Storage LLC, and Cielo Vista Power LLC.
5. Consider, deliberate, and possible action to generate a monthly report on updates provided by Cielo Vista Solar LLC, Cielo Vista Storage LLC, and Cielo Vista Power LLC. Including their request for Tax Abatement, progress on Well Applications, Hydrology Studies, to monitor and protect groundwater.
